New Business:

Camp update: Tess Flannery reported

- 1. Programming: as of Mid-December, Resident camp was more than ½ full, bookings are strong. Winter Family Camp is President's Day weekend, Small groups coming out and EE. New Bosco Cabin will have 20 beds which help with waiting lists.
- 2. University of Akron Engineering students under direction of Bob Benell have been out twice in 2 different groups. They are studying Hydrology at Camp including the water paths and underground water drainage. Their design projects are due mid-April.
- 3. Menards Project on Medina Line Rd to Pinnacle Sports is affecting the community including Camp. Community is against the project as it can cause problems with traffic and storm water drainage. Residents of Bath, the Yellow Creek Conservatory, Parks department and Catholic Charities are working to block this project. A letter writing campaign through Catholic Charities has been approved. Tess to provide more information when available.

The Treasurer respectfully submits to The Board and to the General Membership of Friends of Camp Christopher seven items:

First, for the month of October 2019, Revenues were \$50.00, and Expenses were \$599.14, resulting in a month ending balance of \$\$27,697.47.

Second, for the month of November 2019, Revenues were \$3240.63, and Expenses were \$10.21, resulting in a month ending balance of \$30.927.89

Third for the month of December 2019, Revenues were \$1668.86, and Expenses were \$33.37, resulting in a month ending balance of \$32,563.38.

Fourth, for the fourth quarter of 2019, Revenues were \$4959.49, and Expenses were \$642.72, resulting in a fourth quarter ending balance of \$32,563.38.

Fifth, for the second half of 2019, Revenues were \$20,522.00, and Expenses were \$5286.14, leaving a second half balance of \$32,563.38.

Sixth, for the year-end 2019, Revenues were \$28,016.30, and Expenses were \$23,062.95, leaving a year-end balance of \$32,563.38.

Finally, \$5495 were generated in memorials to FoCC in 2019. Of this, \$3360 was donated in memory of Tom Gannon. Meeting the threshold limit of \$2000 as dictated by adopted policy, the amount of \$3360 will be placed, by the Board of FoCC, into the existing restricted account to serve as an Endowment for Camperships. This amount will be recorded as a Board Expense on the Treasurer's Report for the month of January, 2020, and will no longer be included in future monthly reports of routine business.

In addition, the existing Campership Endowment of \$10,543, held in a CD account at Huntington Bank, generated \$277.43 in interest in 2019.

Thus, adding the Gannon funds and the 2019 interest to the restricted account, the Campership Endowment now totals \$14,180.43.
