17-18 utility poles need replaced. Thompson Electric is doing the work, but delayed by emergencies. Hopefully, the work will be completed by Spring. PA system is included.

Gathering estimates for pile foundation work under cabins

Considering building a road from the Maintenance Facility to the back of camp, to aid general operations including access for the Fire Dept., should it be needed.

Tim Lilley questions Camp Director position posting. Tess has an intern currently that may be able to move up to this spot.

September Song fees have increased. A date on the website is incorrect.... Sept. Song ends on Friday. Increased camper fees are to offset/allow staff raises and to be competitive.

Patti Longville asks about Sunday registration plans. Tess reports at this time they are scheduled to be the same as last year. However, this could change.

Transportation-not planning on picking up campers at this point.

Preparing for full registration this summer. 100% capacity.

Harvest Moon Program looking very possible, protocols will be announced later.

Covid protocols in general need to be flexible and reflect the current situation.
