- Catholic Charities campership data: Irene Lawrence discussed at today's board meeting. An email request will be made to Olivia for a breakdown of how campership dollars are being spent.
- Olivia's request:
 - Potential proposal for a butterfly house at camp: Camp has applied for a grant for up to \$5,000 from the Ohio American Camp Association. It is intended to help camps create a new program to benefit campers. A few years back, Allen created a butterfly house that campers used in the summer. It only lasted for two seasons as it was not intended for long term use. The idea for this grant was to build a more permanent structure for a butterfly house that could last into the future. They contacted a storage barn company to build a concrete pad, wood structure, and corrugated plastic roof. We are hoping to apply for this grant and receive \$5,000. However, the cost of the entire project is closer to \$10,000. Would FOCC be able to contribute \$5,000 to complete the butterfly house project if the ACA grant is received.
 - Board recommends to the membership the FOCC allocate \$5,000 for the butterfly house project if the \$5,000 ACA grant is received.

 - Hiring opened up in February.
 - Working to grow some of the programs, specifically resident camp and sum fun.
 - FOCC has donated \$10,000 for camperships this year, a \$3,000 increase. Other
 contributors have also donated for camperships. Last year all who applied for a
 campership received one. If more money is needed for camperships, Olivia will reach
 out to FOCC at the next meeting.
